I understand that if this account becomes delinquent:

1. My culinary water supply (Hooper Water Improvement District or Taylor West Weber Water) will be disconnected until the account deficiency has been collected. This action if necessary, also accrues additional fees, interest, and charges that will be added to my account, as well as additional charges to reinstate the culinary water supply.
2. Seek the services of a collection agency for all delinquent charges and any fees imposed.
3. File a Property Tax Lien with the Weber County Treasurer's Office for all delinquent charges and any fees imposed. All laws applicable to the levy, collection and enforcement of the city real estate property taxes shall be applicable to such an assessment.

In the event legal action is required by Hooper City to enforce this agreement, I agree to pay all collection costs including reasonable attorney's fees to Hooper City.

I understand that the billing is billed at the beginning of the month for that month's service. It is due by the 15<sup>th</sup> with finance charges being applied after the 25<sup>th</sup> of the month.

I am aware of my obligation by ordinance to sign up for secondary water service if it is available to my property, when certain conditions exist, and agree to do so. (Ref. Ord. No. 2005-13)
